# Schedule A to the NATIONAL SERVICE AND MAINTENANCE AGREEMENT

# **ARTICLE IX**

#### **Classification of Employees**

**Paragraph 15** – Modified to include repair of centrifugal, absorption, screw chillers and ammonia refrigeration systems.

# **ARTICLE X**

#### Hiring and Use of Employees

**Paragraph 27 & 97** – Modified to include the assignment of up to a maximum of six (6) employees from the Employer's regular work force in the states of Alabama, Florida and Georgia.

## ARTICLE XII Wages, Benefits, and Hours of Work

**Paragraph 40** - Servicemen - Rate of pay shall be not less than 50% or more than 80% of the Service Journeyman wage rate. The Employer, with mutual agreement of the local union, will establish wages for each Serviceman based on experience and training.

**Paragraph 41** - Service Apprentices - Rate of pay shall be a percentage of the Service Journeyman rate as stipulated below:

1 <sup>st</sup> year– 40%	2 <sup>nd</sup> year – 50%	3 <sup>rd</sup> year – 60%
4 <sup>th</sup> year – 70%	5 <sup>th</sup> year – 75%	-

Paragraph 42 - Service Tradesman - Rate of pay shall be 50% of the Service Journeyman rate.
