## MCAA Committees

### **Advanced Leadership Institute Committee**

Provides industry input and stewardship to ensure that MCAA's Advanced Leadership Institute (ALI) remains relevant to today's business leaders.

### **Career Development Committee**

Identifies and promotes career development education and resources to assist members with their recruiting and retention efforts.

### **Education Committee**

Tracks industry issues and trends and develops relevant programming for the MCAA Annual Convention and other educational events.

### **Fabrication Committee**

Monitors the fabrication landscape to ensure that MCAA's Fabrication Conference and resources accurately reflect industry practices.

### **Government Affairs Committee**

Tracks federal legislation and ensures members' views are represented in the national legislative process.

### **Industry Improvement Funds Committee**

Monitors and shares information on Industry Fund programs, including through the Industry Improvement Funds Conference.

### **Innovative Technologies Committee**

Determines what education and resources members need in order to keep pace with technology and enhance their bottom lines.

### **Management Methods Committee**

Suggests topics to ensure MCAA's Management Methods resources reflect industry best practices and solicits entries for the E. Robert Kent Award for Management Innovation.

### **Plumbing Contractors of America Board of Directors**

Represents the interests of member plumbing contractors through lobbying and collaboration with other industry groups.

### **Project Managers Education Committee**

Oversees curriculum development for the Institute for Project Management (IPM) and the Advanced Institute for Project Management (AIPM).

### **Safety & Health Committee**

Produces safety and health resources and training programs, informs members about relevant safety and health issues and administers MCAA's safety awards programs.

### **Women in the Mechanical Industry (WiMI) Committee**

Plans all programming and resources for WiMI including annual conference, webinars and programming at MCAA and MSCA conferences and other events. Supports mentor/mentee program and assists with selection of WiMI scholarship winners. Works with UA to support Tradeswomen Build Nations.

## MSCA Committees

### **MSCA Education Committee**

Develops all training resources and educational programs for MSCA. This includes planning of MSCA conference including topics, speaker recommendations, roundtables, exhibitors, theme, etc. Play an active role at the conference as hosts for all speakers and exhibitors, serve as facilitators for roundtable discussion sessions and provide additional support as needed. Supports the MSCA Sales Institute through program updating and class facilitation.

### **MSCA Labor Committee**

Meets jointly with the UA to administer the National Service and Maintenance Agreement and help support and grow the service industry through our joint partnership. Supports local Oversight Committees and considers grievances as necessary. Answers members' questions regarding National Agreement interpretation or other labor related issues.
